

# The Camden Higher Education and Healthcare Task Force: A Winning Investment for the City of Camden

February 2012



Camden's higher education and healthcare institutions are leading the city's revitalization. These anchor institutions are key to the city's economic health because of their employment and significant purchasing power. They are fundamentally rooted to Camden by real estate, capital investments, and a client base, among other factors.

Since 2002, Camden's anchor institutions have worked collectively as never before, through the Camden Higher Education and Healthcare Task Force. It includes eight core "Eds and Meds" members: **CAMcare, Camden County College, Cooper University Hospital, Lourdes Health System, Rowan University, Rutgers-Camden, The University of Medicine and Dentistry of New Jersey, and Virtua.**

This report details their collective economic, educational, and health impact on the City of Camden and the surrounding region.



### CAMcare

A federally qualified health center that has been providing high-quality comprehensive primary healthcare at four Camden locations for 30 years



### Camden County College

A comprehensive public community college that prepares students for success at three campuses, including its growing Camden campus



### Cooper University Hospital

A leading provider of comprehensive health services, medical education, and clinical research that has made Camden its home for 125 years



### Lourdes Health System

**Our Lady of Lourdes Medical Center**  
An acute care hospital and regional referral center committed to promoting healthy communities and ensuring access to all



### Rowan University

A public university offering undergraduate, graduate, and professional degree programs in Camden



### Rutgers-Camden

A research university with an international reputation for teaching, research, and service, with a vibrant 40-acre campus in the heart of downtown Camden



### The University of Medicine and Dentistry of New Jersey (UMDNJ)

A health sciences university, with a medical school campus that educates and trains students in Camden and provides EMS services.



### Virtua

An emergency and outpatient services center serving Camden 24/7, which houses a variety of other healthcare services as well as education and social services

## Employment Trends in Camden

Universities and healthcare institutions have long taken the lead in urban redevelopment. According to the Bureau of Labor Statistics, healthcare is the fastest-growing sector of the economy, with educational services close behind.

These national trends are even more prominent in Camden. It has weathered the grim economy, losing only 2 percent of its jobs over the last five years, and has added to its job total since 2002 (the earliest date for these Census employment data). This is promising considering that the City cut 31 percent of its public administration jobs in that span.

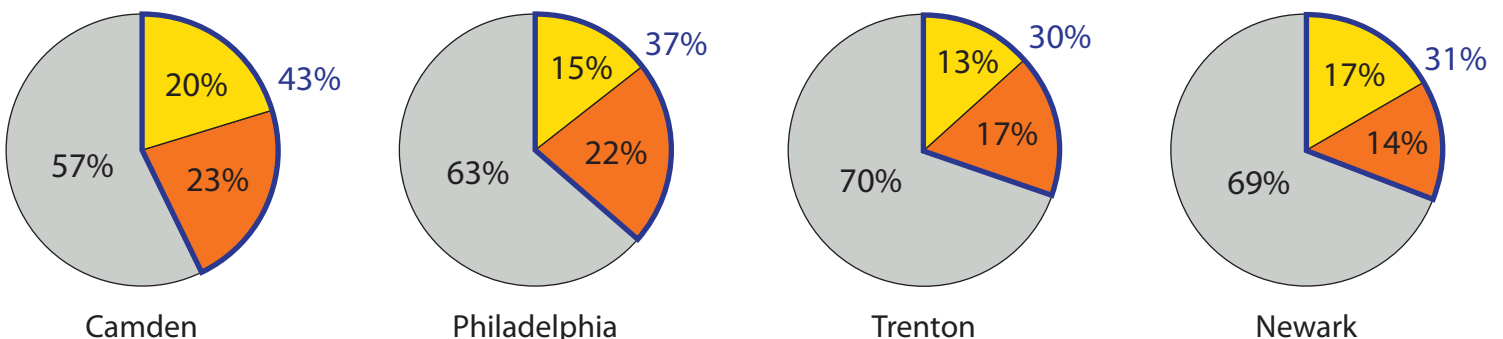
Much of its growth in employment has taken place within the healthcare and social assistance as well as education sectors, **where Camden is a leader among comparable cities.**

The Task Force institutions **employed 9,253 people and provided jobs for 997 Camden residents in 2011** (692 full-time and 305 part-time). Despite taking a hit from the economy and dropping in 2011, this total is still 4.4 percent higher than it was a decade ago.

*The healthcare and education sectors account for 43% of all jobs in Camden, a higher rate than nearby cities Philadelphia, Trenton, and Newark.*

Employment by Job Sector for Camden and Nearby Cities

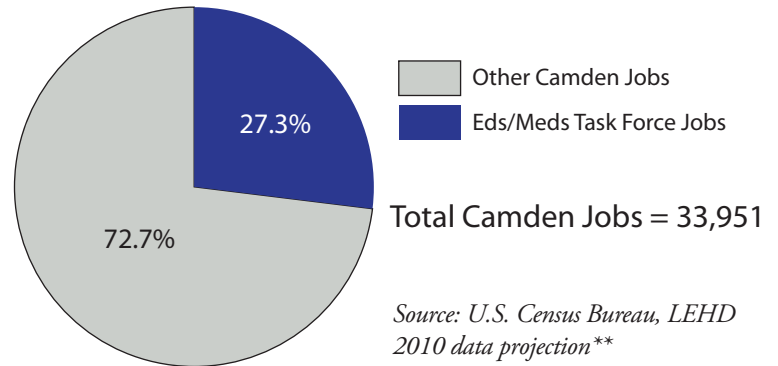

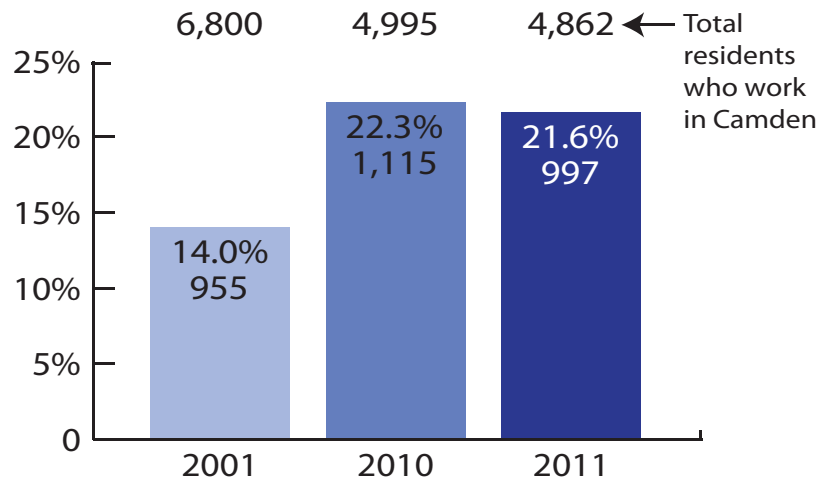

## Economic Impact

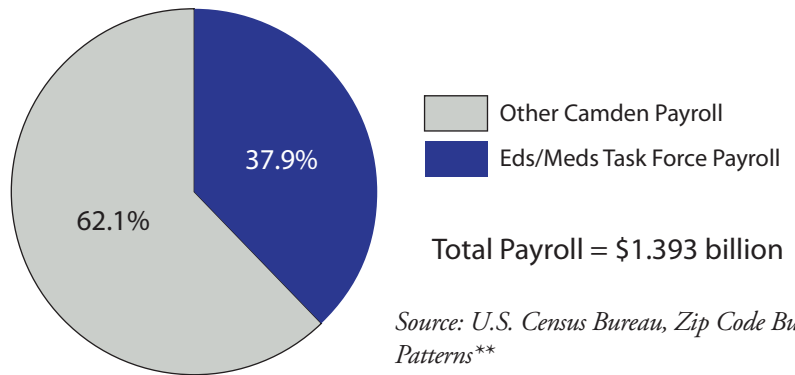
The Eds and Meds institutions bring strength and support to Camden, acting as an economic engine for stability and growth. Wherever they live, the 6,667 full-time Eds and Meds employees bring their incomes into Camden every day. In all, Task Force employees **earned nearly 38 percent of the total payroll in Camden.**

The **total Task Force payroll is more than \$528 million annually – an increase of nearly \$8 million from a year earlier and \$73 million since 2001.** As such a large portion of Camden’s overall payroll, these institutions will continue to play a major role in shaping the city’s revitalization. In all, 86 percent of the income went to full-time employees, and 14 percent to part-timers.

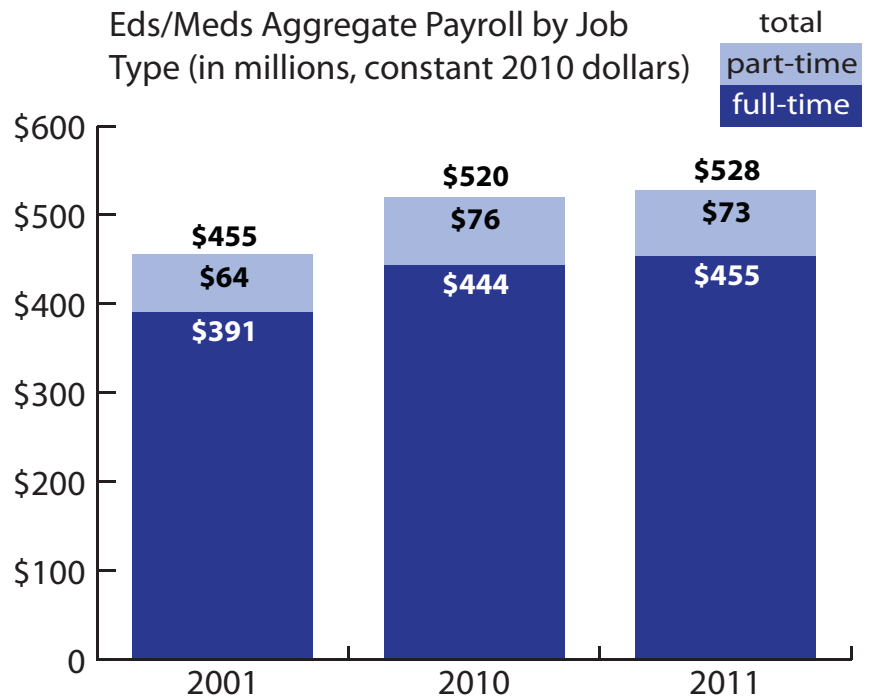
### Camden residents earned more than \$32 million in wages in fiscal year 2011.

These jobs aren’t always reserved for the richest individuals, but such income earned by residents makes a middle-income lifestyle possible for an increasing number of families. Further, these wages are spent on food, products, and services in the city, creating a ripple effect and setting up the essential cycle necessary for a diverse and resilient economy. The Eds and Meds institutions also provide many residents with health and retirement benefits, eligibility for tuition reimbursement, and other benefits. The Eds and Meds employers have been recognized as Best Places to Work by publications across the region such as the *Philadelphia Business Journal* and *NJBIZ*.

## Education and Healthcare Impact

### Education

The Eds and Meds Task Force educates Camden's best and brightest, while also providing a range of higher education opportunities for people of all ages and backgrounds. The Task Force's programs serve those wishing to enter the job market, upgrade skills, earn degrees, or prepare for professional certifications.

*The four educational institutions on the Task Force taught over 11,500 students in 2011 and conferred nearly 1,700 degrees.*

In the 2010-11 school year, more than 11,500 students were enrolled or taking courses at the Task Force's educational institutions – an increase of 7 percent over 2009-10 and 18 percent over the last decade. That one-year difference was entirely from an increase of 151 resident students, who will continue to make a positive imprint on the city. In 2010-11, a total of 2,191 students lived in Camden and 209 residents received degrees, a 27-percent increase from a year earlier.

### Healthcare

The Task Force's medical institutions care for Camden's sick regardless of their ability to pay. Camden residents have access to five unique institutions across the City to provide everything from primary care to dental work to trauma visits. When problems arise, City emergency departments take care of Camden's population 24 hours a day. Cooper, Lourdes, Virtua, CAMcare, and UMDNJ together saw 295,475 total health system visits from the 77,000-plus Camden residents.

## Impact on the Community

Whether it's housing, community parks, or investing in "human capital," the Task Force is committed to helping realize Camden's great potential and improving quality of life in the City. For example, various members of the Task Force financially support the Camden Special Services District, an effort started in 2005 by Cooper's Ferry Partnership, which uses "ambassadors" to greet pedestrians and keep the City clean and safe.

New Jersey's investment in Camden's Eds and Meds has led to a continuous stream of capital projects, which create jobs and spur the local economy. At a time when public jobs are being slashed, anchor institutions in Camden are building capacity to better serve the City and the region.

### Major Planned and Recent Capital Projects

**Rutgers Graduate Dorm** (Expected completion in August 2012): \$55 million dorm at 330 Cooper Street will include 102 units and house 350 graduate students, and it will include retail on the ground floor. (See Figure 1)

**Cooper Medical School of Rowan University** (Expected completion in 2012): The \$139 million project will create a 200,000-square-foot facility along South Broadway and Benson Street. The inaugural class of 50 students will start in August 2012.

2013): The \$100 million project is slated to break ground in April 2012. As a part of the new medical school, it will house all outpatient cancer services. (See Figure 2)

**Haddon Avenue Transit Village** (Expected completion in 2014): Lourdes' 15-acre redevelopment project will include office space, a grocery store, residential housing and structured parking.

**Early Learning Research Academy** (Completed September 2011): Rutgers' \$8.5 million project created a 12,000-square-foot space to serve 126 children up to age 5.

**Barnes & Noble Book Store** (Completed July 2011): The \$350,000 project renovated 13,500 square feet and now serves Camden County College, Rutgers, and Rowan
